MINUTES OF THE BOARD OF DIRECTORS MEETING PALM SPRINGS FRONT RUNNERS & WALKERS FEBRUARY 12, 2019

The meeting was called to order at 6:05 pm. Present, and constituting a quorum were: Brian Eggert, Michael Ambrose, Craig Wortendyke, Tom Snyder and Curtis Channell. Absent: Reese Nottingham and DeLon Gobeli. Board secretary candidate, Don Ricart, was also present.

Brian recommended that the board work on implementing an annual "Strategic Plan" as outlined in the Road Runners Club of America (RRCA) newsletter. Michael proposed that future budgets be determined by the board in December so that membership dues can be set in time for the January renewal period, based on budgetary requirements. In Reese's absence, Brian presented the January financial statement which did not reflect new 2019 budget item additions. Brian noted that Reese will need to meet with former treasurer, Keith Culver, to help with preparation of the 2018 tax returns, and if Keith is not available, Don Ricart, being a former CPA, may be asked to assist.

Brian noted that each meal at this year's anniversary dinner costs the club \$42, but members will be charged only \$35. The board voted unanimously to subisdize the dinner in the amount of seven dollars per member.

There will be a St. Patrick's theme to the dinner, according to Brian. Entertainment will be provided by Desert Winds Freedom Band and Keisha D. A brief discussion was held on the procedure being used to determine the winner of the Founders Award, which will be given at the Anniversary dinner. As of the board meeting date, 23 have signed up for the event.

In the Social/Travel Director's absence, Brian shared an email from DeLon regarding upcoming social events, including a mixer at Moxie on March 26, a mixer at The Roost on April 3, and a breakfast at the Runway on April 6. Brian reminded Tom that board candidates will need to be listed in the March issue of the newsletter. Tom said the deadline for the March issue is February 25.

Curtis reported that current club membership stands at 333. He has produced 75 name tags so far and will have badges ready for the anniversary dinner attendees. Brian, in response to a question from Michael, stated that members stay on "active" status for 30 days after their membership expires. Brian presented a list of members who have not renewed. Brian gave the nominating committee report for the upcoming board elections. Candidates for open positions are:

- Vice-President, Michael Ambrose Secretary, Don Ricart
- Membership Director, Curtis Channell Newsletter Editor, no candidates
- Webmaster--Eric Akin

The Board unanimously approved the appointment of Eric Akin as webmaster to serve the remaining portion of the current term. Eric will then run for a two-year term in the March 16 election.

An inventory of items in storage was provided to the board, in which DeLon had indicated some items he would like to retain.

The Board voted unanimously to proceed with a Pride Run & Walk in 2019. Michael made a motion that the proceeds of the 2019 Pride Run & Walk be split equally between the LGBT Center and Safe Schools of the Desert, and that member sponsors will be able to select which of the two organizations their donation goes to. After discussion, the motion passed unanimously.

Michael would like to see a PSFR&W t-shirt that could be worn at various events to present a unified and identifiable club presence. The club would have to find a vendor that can make shirts in small batches as needed.

The meeting adjourned at 7:17 pm.



Half Marathon 10K-5K


Melrose District and Central Avenue Corridor Saturday, March 23, 2019

Phoenix Frontrunners will have their 2019 Pride Run and Walk on Saturday, March 23rd, in downtown Phoenix. There will be a 5K run and walk, a 10K and a half marathon. We are encouraging as many of our local runners and walkers as possible to participate, both to increase our visibility and to encourage the members of the Phoenix club to join us for our Pride Run and Walk in November. Please note that the Phoenix Pride Festival is not on the same weekend as the Pride Run.

Course description: Run, walk or wheel through Central Phoenix using 7th Avenue, the Grand Canal, and Central Avenue. The Half Marathon. 10K and 5K are street courses with minimal elevation changes and turns that also use paths on the Grand Canal. Like the 10K and 5K, the Half Marathon is a fast, flat course perfect for a PR (Personal Record or Personal Best), making it an ideal training run for the Boston Marathon. This event is light rail accessible within approximately a half mile of start, finish, and expo located in the heart of the Melrose district. As a participant, 21 years of age or older, your first beer is on us. Make sure you plan to stick around and enjoy the Melrose Block Party with a fun atmosphere, entertainment, exhibitors, and unique local Melrose district businesses.

Have a great month. Enjoy the last newsletter until someone steps up to manage it.


Have You Renewed Your Membership?

If you have not renewed your membership yet, you will no longer receive emails alerting you to upcoming Club activities. Memberships were due on Feb. 1st. We set a grace period of 30 days which ends on March 1st. Membership is ONLY \$30. We currently have 256 renewed Members and 25 new Members. We still have 86 Members that have not renewed. Most of the time we are sure that it might just be a busy time and you might have overlooked the renewal notice. If you have decided not to renew your membership for 2019 on purpose, we are sorry to see you leave us.

As most of you probably already know, our Front Runner Organization is a non-profit organization under Section 501(c) (3) of the Internal Revenue Code. The bulk of the Club's revenues come from our membership dues. Roughly half of the annual expenses are for administrative expenses such as RRCA dues, RRCA Liability Insurance, Officers Insurance, credit card processing fees and Club Express monthly maintenance fees. We also allocate funds for promotional activities such as fees for information booths at local events (such as Info Go Go, Health Run Expo and AIDS Walk) giving us more visibility in the community. A portion of your dues go for social activities and anniversary dinners at reduced prices. This year, Members will receive \$7.00 off the cost of this year's anniversary dinner. We usually allocate a portion of the dues revenue at the end of the year for donations to other local non-profits, such as Mizell Senior Center.

The Palm Springs Front Runners and Walkers by-laws state: All Elections choosing the Directors of the Palm Springs Front Runners & Walkers will be conducted as follows:

E. If a secret written ballot is necessitated by virtue of having more than one candidate for a given position, a secret ballot will be sent to the membership via the March newsletter. Only members in good standing at the time of the election may vote. Ballots will be counted on the third Saturday of March by the Secretary and Treasurer who will then certify the election of new Board members.

F. If only one person is nominated for each open position, a vote of acclamation will then be conducted on the third Saturday of March. A prior two-week notice to this effect must be given.

At this time, the nominating committee only has one candidate for each position so a secret written ballot will not be generated.

We are very sorry to see two of our current Board of Directors deciding to step down this year leaving, 2 open positions. Both members have served two terms on the Board. Craig Wortendyke (Secretary) and Tom Snyder (Newsletter Editor) will both be stepping down at the end of their terms.
